Thank you Walnut Creek school families and community. Together we are stronger.

Through your generous support, the Walnut Creek Education Foundation K-12 (WCEF K-12) was able to contribute \$640,678 to the Walnut Creek School District and Las Lomas High School (Acalanes Union High School District) for the 2010-2011 school year. WCEF was able to preserve critical programs and personnel for our children in spite of state and federal budget cuts to education.

While our school families provide the majority of WCEF's funding (88%), the Walnut Creek community also plays a vital role in supporting all of our students in kindergarten through the twelfth grade. In the past year, Robert Anthony Strategic Marketing and Design, Sports Basement, Whole Foods, Minuteman Press of Lafayette, Wine Thieves, AlphaGraphics, Walnut Creek Sports and Fitness, Rubens Nunnemaker LLP, CPA and many other local businesses lent their support, working with the Foundation to raise necessary funds. Together we are stronger.

As you will read in the following pages, WCEF's mission is alive and the foundation continues to provide vital support to the success of all our children at every age – each and every year.

The Walnut Creek Education Foundation raises funds to preserve and enhance the education of each student in the Walnut Creek School District and Las Lomas High School in the Acalanes Union High School District through a broad-based community effort.

# who we are

## THE WCEF ORGANIZATION

The Walnut Creek Education Foundation was established in 1983 and existed for many years as a small, supportive foundation for the Walnut Creek School District (WCSD) K-8. In 2005 WCEF merged with the Las Lomas Foundation, which was serving Las Lomas High School in the Acalanes Union High School District (AUHSD). This merger united all parents and the community in one common goal: to provide the WCSD and Las Lomas with the financial means to assure excellence in the

education of all our children. Our Board of Directors, representing many facets of our community, are volunteers with and without children currently attending our public schools. All board members share an ongoing commitment to the high standard of education in Walnut Creek. They believe that our children and our schools are our community's greatest assets. Each of the seven schools WCEF serves is represented on the Board of Directors and Executive Committee. Every aspect of our fundraising effort is performed by dedicated and enthusiastic volunteers who bring a multitude of talents and skills to each assigned task.



## WHAT WE DO

WCEF actively seeks donations in support of our schools via the Annual School Campaign, which kicks off each year in May. Our annual budget is developed collaboratively with the Walnut Creek School District and Las Lomas High School (AUHSD) through a yearly prioritization process and in accordance with our funding guidelines. The budget serves as the basis for our annual fundraising goal.



## HOW WE DO IT

WCEF employs a variety of ways to fundraise throughout the course of the entire school year. The Annual School Campaign, which is a check writing campaign, launches in May each year. Concurrently, the Scholar Circle kicks-off their campaign as well. Scholar Circle donors are part of a group of parents and community members that commit to maintaining the quality education in our outstanding schools by giving at an exceptional level. The Annual Campaign continues throughout the school year, utilizing a variety of methods to reach out to families, update the Foundation's progress, and encourage continued donations.

Community members and businesses also play a vital role in the success of WCEF. Many events are held to raise funds to support student programs. Several businesses provide thousands of dollars of in-kind donations throughout the year as well.

An Endowment Fund has also been created. Though only in its early stages, WCEF is looking to provide a dependable, long-term source of funding for our schools through this fund.



## WHY WE DO IT

Funding of public schools in the state of California has changed dramatically over the last quarter century. Since our public schools receive the majority of their funding on a per student basis from the state government, the state deficit has resulted in dramatically reduced allocations to education. California schools, including schools in our districts, are in the midst of the most critical fiscal crisis in the state's history. The massive deficit severely impacts our state's per pupil funding and threatens the loss of teachers, academic classes, and student support services.

The spiraling state education budget is not new to our schools. In partnering with our parents and community, WCEF is uniquely poised to step in and help fill the budget gaps created by reduced state funding. Our goal remains steadfast: to do all we can to raise sufficient funds to maintain the quality educational programs that are offered through our school districts and that our children deserve.

## Every Student, Every Day WCEF & Las Lomas High School

In 2010-2011 WCEF committed \$190,678 to fund academic programs, student support services, and instructional materials at Las Lomas High School. Money was raised in a unique partnership with the LLHS Associated Student Body (ASB), the Parent, Teacher, Student Association (PTSA), and the Performing Arts Foundation (PAF). Funded programs included:

## Every Student, Every Day WCEF & Our Five Elementary Schools

Buena Vista, Indian Valley, Murwood, Parkmead, Walnut Heights

At the elementary level, WCEF funds programs that otherwise would not exist. These programs include standards-based instruction in Art, Music, and Physical Education. In addition to these programs, WCEF funds librarian hours and collaboration time for the classroom teachers. Collaboration time allows every teacher to meet with an academic coach and other grade level colleagues to improve teaching strategies and refine curriculum to better meet the needs of all students. Every year WCEF has been able to provide the Walnut Creek School District with the necessary funds to be able to continue these programs that the schools' students need and deserve.

# donor sources

In 2010-2011, the Walnut Creek Education Foundation K-12 raised \$911,907. The funds came from five primary sources: our parents, business donations, community donors, dedicated fundraising events and a one time grant from a Supporting Foundation of the Jewish Community Endowment Fund. Parents are WCEF's largest constituency. Many receive matching donations from their employers. During the 2010-2011 campaign year a total of 1,475 contributors donated \$662,766.

WCEF has a base of business partners who either make a cash contribution or donate their services to benefit the foundation and the students we serve. Local businesses contributed \$41,962 and more than \$25,000 of in-kind donations, including printing, advertising, and special event venues.

WCEF received donations from 99 community donors consisting of parent alumni, District staff and teachers. Donations were made both to the WCEF general fund and the Michael De Sa Memorial Scholarship fund.

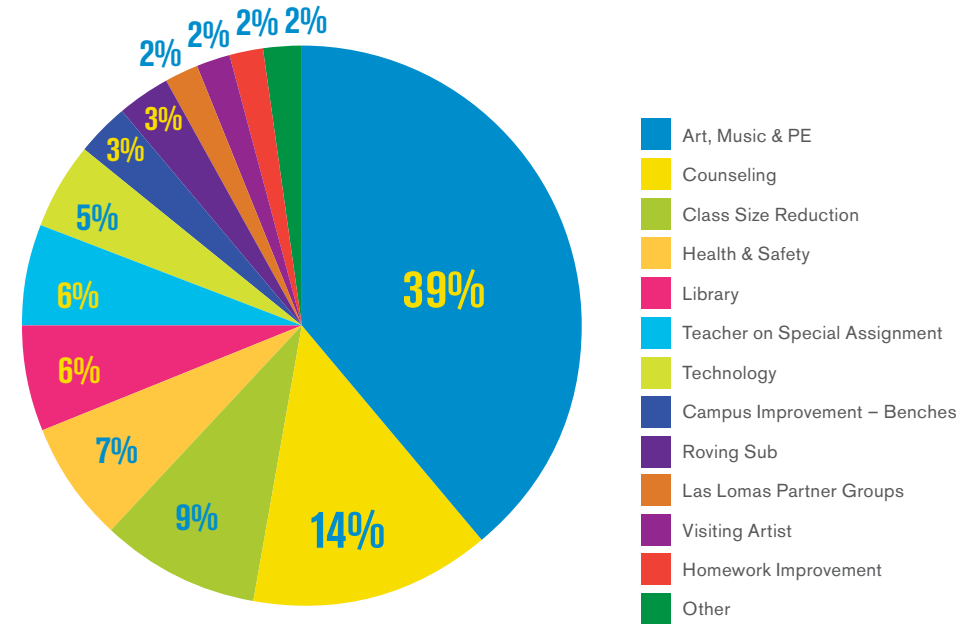
